**THE FOLLOWING IS REQUIRED:**

1. All students MUST complete this form and return it to the Business Office for registration of their car(s). When this form is received, a parking permit will be issued. This permit is to be prominently displayed when the care is parked in the CCHS student parking lot.
2. There is a registration fee of \$5.00 associated with obtaining the parking permit, please review #4 completely for parking guidelines. Some changes have been instituted for the safety and security of our students and our property.
3. **All cars will display a permit**
4. Any vehicle parked in the CCHS lot after September 11, 2009 that is registered, but does not have a permit displayed will be subjected to a \$5.00 first offense fine. The second offense will be a \$10.00 fine and the parking permit will be temporarily revoked. A third offense is subject to being towed. The police will be called with regard to any vehicle in the parking lot that does not have a permit and is not registered.
5. Students may park their cards only in the student parking area located at the north end of the arena parking lot (immediately outside of the fence around the school). Any student who parks in a non-designated area will be fined \$10.00 for the first violation. The second offense will be a \$10.00 fine and the parking permit will be temporarily revoked. The police will be called with regard to any vehicle in our student or faculty lot that is not identified.
6. The student must observe a 20 mph speed limit while on school or arena property, follow safe driving practices and exercise courtesy at all times.
7. For the safety to persons and protection of vehicles, students must not block the vehicles of other students. The parking lot is off limits during school hours. Once cars are parked, they must remain parked until the end of the school day. Students found in the parking lot or leaving the parking lot without permission during the school day will be subject to school disciplinary action.
8. Students are required to obtain a new parking permit each school year. The previous year's permit is not valid.
9. The above student has my permission to drive to school. This is with the understanding that Catholic Central High School will not assume responsibility for accidents or injuries caused by the driver or to the driver and/or his/her passengers.
10. Catholic Central High School shall not be held liable for any claims of theft or damage to any vehicle while parked on school or arena property.
